## AMUNDI RESPONSIBLE INVESTING – JUST TRANSITION FOR CLIMATE

Shareholders of the **JUST TRANSITION FOR CLIMATE** sub-fund of the SICAV **AMUNDI RESPONSIBLE INVESTING**, the management company of which is Amundi Asset Management, are hereby informed of the following modification :

the sub-fund, which is currently classified as an Article 9 product within the meaning of the SFDR (Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector (the “Disclosure Regulation”)), will be reclassified as an Article 8 product with effect from 30 December 2022.

This reclassification is the result of the successive clarifications made to the Disclosure Regulation, and more specifically, in connection with the forthcoming implementation of the Level 2 requirements of this Regulation.

All other ESG (environmental, social and governance) characteristics and the investment policy will remain unchanged.

This change does not need to be approved by the French Financial Markets Authority (Autorité des Marchés Financiers), and does not require you to take any specific action.

The regulatory documentation for your sub-fund is being updated to reflect these changes from 30 December 2022.
